2020 ELECTION OF 1 DIRECTOR TO A CASUAL VACANCY

NOMINATIONS

Nominations are invited for the following position on and from Sunday 22nd March 2020

Director (1)

Candidates must have completed a minimum of 5 years current and continuous membership. All Nominators and Voters must have held continuous membership of the Club for at least 2 years prior to the AGM.

Candidates and their (2) nominators must be financial members from the following classes of membership, Standard, Concessional, Foundation Life, Companion Life, 50 Year, or Honorary Life members of the Club.

Nominations must be in writing and comply with the Club Constitution/By-Laws and any relevant directions given by the Returning Officer. Nomination forms are available from the Club or from the Returning Officer.

LODGEMENT OF NOMINATIONS

Nominations must be received by the Returning Officer, Philip Binns, or the Chief Executive Officer of the Club by no later than 4.30 pm on Sunday 19th April 2020

Nominations may be lodged with the Returning Officer up until 5.00 pm Friday 17th April 2020.

After that time and up to 4.30 pm, Sunday 19th April 2020, to the Chief Executive Officer at the Club.

Should more than the required number of nominations be received for the position a draw will be conducted to determine the order of candidates' names on the ballot paper at the Club at 5.00 pm, Sunday 19th April 2020. Candidates or their representatives are invited to witness the draw.

CANDIDATE PROFILE

Each nomination may be accompanied by a Candidate Profile form. A completed Candidate Profile Form is not compulsory, but is highly recommended. Details from the Candidate Profile will be available in the Club prior to voting.

Details regarding completion and lodgement will be printed on the forms, which are distributed with the nomination forms.

VOTING AT CLUB

If an election is necessary voting will be conducted at Wentworthville Leagues Club, 50 Smith Street Wentworthville.

Due to the nature of election and in accordance with Wentworthville Leagues Club Constitution Clause 128 (a)

128. (a) *In the event of a casual vacancy/vacancies of Directors in circumstances where there are sufficient numbers of Directors to achieve a quorum, the Board shall continue without replacement providing there are sufficient Directors available, capable of forming a quorum at a Directors meeting, until the next Annual General Meeting (not being a meeting at which the Biennial Election of the Board is conducted), when an election, conducted in a manner prescribed by the Board, shall be held to fill the vacancy for a period until the next Biennial Election of the Board".*

It has resolved by the Board of Directors that the voting for the 2020 election of one director will commence at 12 Noon and finish at 8.00 pm daily from Thursday 21st May 2020 until Sunday 24th May 2020 inclusive.

Eligible members must produce their current membership card in order to receive a ballot paper. The method of voting will be First Past the Post. Members must vote for a single candidate only. The ballot will be counted at the Club commencing at 10.00 am on Monday 25th May 2020. Each candidate may appoint up to two (2) scrutineers to witness the count.
